In the 2018-2019 school year, the school began offering CTE classes in computer technology and health careers. These CTE pathways continued into 2019-20. The school also partners with Humboldt County Office of Education to offer classes in construction technology, and with local non-profits to offer classes in industrial arts (blacksmithing, woodworking, etc.). Students are encouraged to concurrently enroll in the local community college where they can take a variety of classes, including many wide-ranging opportunities for career training.

Parents are encouraged to participate in the school. Parent involvement in the education of the student is critical, as most learning takes place at home. Parents are also encouraged to become members of the School Leadership Team and Governance Council where decisions for the school are made.

Twice yearly full-day and/or regular virtual parent workshops are held on a variety of topics including Native American education, effective ways to teach writing, movement and learning, learning styles, math standards, test preparation, homeschooling, high school volunteer and career training, and more. The school's once-a-year curriculum share and open house is the perfect opportunity to browse curriculum, ask questions of those who have used each one, and to network with other home school parents. Two 6-week classes are offered for parents new to homeschooling and have TK-2nd grade students, helping them organize and maintain a creative, effective, and academic learning environment.

The school has a safety coordinator and a safety team, who work with the director, to create and implement a board approved comprehensive school safety plan. The safety team meets regularly to review elements of the safety plan and develop/update procedures. Every August at the teacher in-service trainings, the faculty is informed about any changes to the safety plan, and procedures are reviewed for the upcoming school year. On-campus class teachers review the plan with students the first week of school. In 2019, the local police department gave a safety training to staff and the safety team worked to implement their suggestions. During the 2019-2020 school year, the safety team updated the facility to safely utilize the space during a pandemic, including the development of handwashing/sanitizing stations, one way hallways, ordering PPE, and other measures.

Types of Services Funded (Fiscal Year 2019-2020)

The school offers a mandatory Academic Support Program to those students who are working below grade level. Students receive an extra hour of tutoring, either face to face or online, in math, reading, and/or writing if they are identified as needing Academic Support services. A weekly math skills class meets to enforce foundation skills for elementary students who qualify. Small reading and writing groups are also offered to students not below grade level who voluntarily sign up for this service. Drop in and virtual math lab is held every day and is an opportunity to get math support for students of all grade levels. A writing lab is open twice a week for accessing help for writing across the curriculum. Alder Grove also utilizes a North Coast Cal-SOAP tutor to instruct students in study skills and other executive function skills, as well as tutoring in specific subjects.
